## MEMBERSHIP CATEGORIES 2024

The Athens Country Club welcomes applications for membership. There is a series of membership categories to reflect the variety of activities available at the Athens Country Club designed to meet the needs of its members. See next page for initiation fee, food minimum requirements, and other applicable fees.

### GOLF MEMBERSHIPS

**Full Golf and Social (one member):** Age 40 and over: Entitles an individual golfing privileges and use of all other amenities \$275.00/mo.

**Full Golf and Social (more than one member):** Age 40 and over: Entitles a family golfing privileges and use of all amenities \$280.00/mo.

**Young Professional:** Entitles an individual or family use of all amenities...

Age 18-23	\$125.00/mo.
Age 24-32	\$170.00/mo.
Age 33-37	\$225.00/mo.
Age 38-39	\$275.00/mo.

### LIMITED MEMBERSHIPS

**Clubhouse Dining** -Entitles an individual or family use of clubhouse amenities. \$ 22.00/mo.

**Social:** Entitles an individual or family use of all amenities except golf. \$100.00/mo.

**Wed/Saturday Golf & Social:** Entitles a returning individual or family use of all amenities with limited golf. \$215.00/mo.

**Non-Resident Golf:** Entitles an individual or family use of all amenities, including golf \$ 150.00/mo.  
To qualify, the member's permanent residence must be outside a 35-mile radius of Athens, Ohio, and the member must reside at said residence a minimum of nine months each year.

**National Golf:** Entitles an individual or family use of all amenities, including golf \$ 80.00/mo.  
To qualify, the member's permanent residence must be outside a 50-mile radius of Athens, Ohio, and the member must reside at said residence a minimum of nine months each year. (8 rounds of golf)

**Corporate:** Special terms for businesses sponsoring up to five employees (ask for a Corporate packet)

**Junior Golf:** Memberships designed for children and high school students (ask for a Junior Golf packet) \$425.00/yr.

## INITIATION AND OTHER CHARGES

**INITIATION FEE** – There is no initiation fee however once application is approved by board, your first month dues/fees are needed in advance.

**FOOD MINIMUM** – The Athens Country Club has a monthly food and beverage minimum, assessed monthly except for the Non-Resident, National, Wednesday/Saturday & Golf, and Junior memberships. Sales tax and tips on purchases are not included base minimum. Food minimums vary depending on the classification and number of persons eligible to use the membership according to policy. On the chart below, “One Person” is defined as a member without a spouse, dependent children or significant other. “Two or More Persons” is defined as a member with a spouse, dependent children or significant other.

### **OPTIONAL SERVICES**

Lockers – Members may rent lockers, subject to availability. Locker rental is billed annually.

Men’s full-size lockers are \$35.00 per year. Women’s half-size 25.00 per year.

Bag Room Storage – Bag room storage and service is \$75.00 per year, billed annually.

Handicapping Service – GHIN handicapping service is \$35.00 per year per participant, billed annually.

**SALES TAX** – State sales tax is charged when applicable including, but not limited to, merchandise, consumables, membership dues, initiation fees, food minimums, carts, lockers, equipment lease fund, capital improvement fund, and assessments.

**ASSESSMENTS** – The Board of Trustees may enact assessments by a majority vote. Terms of assessments may vary.

**DUES AND FEES** – The ACC membership is an **annual contract** with the term being January through December. Dues for the year may be paid annually, semi-annually, quarterly, monthly, or other payment schedule as approved by the Board of Trustees. Dues and fees may be restructured by majority vote of the Board of Trustees.

A membership initiated in any month after January runs for a 12-month period for the first year (e.g. June through the following May). Extending a membership beyond the first 12 months carries an obligation for the remainder of that calendar year. On the following January, the membership automatically renews through December unless a written resignation is submitted prior to January 1.

**VOTING PRIVILEGES** – Full Golf and Social, Young Professional, and Social members have voting privileges (one vote per membership). Clubhouse Dining, Non-Resident, National and Junior members do not have voting privileges.

**LATE PAYMENT PENALTY** – A 10% late payment penalty will be assessed on balances not paid by the due date.

**ACCEPTANCE** – Each member and his/her family agrees to abide by all terms, policies, regulations, and by-laws of the Athens Country Club.
